The Transnational Dispute Management (TDM, ISSN 1875-4120) journal focuses on the management of international disputes, especially the rapidly evolving area of investment arbitration as well as other significant areas of international investment (such as for example oil, gas, energy, infrastructure, mining and utilities). TDM publishes articles covering both formal adjudicatory procedures (mainly investment and commercial arbitration) and also mediation and other ADR, negotiation and managerial ways to manage transnational disputes efficiently. Submission Guidelines

General

- Written in MS Office Word
- Checked for Spelling & Grammar
- Please use standard legal citation methods using footnotes (not endnotes)
- Include an executive summary of the article (150-200 words) to the beginning of the paper
- As an online publication we can publish articles of any length, from a fairly short comment on recent developments to full length academic papers or reports of hundreds of pages incl. Annexes. Minimum word count: 5000+.
- Do not include a table of contents unless your paper exceeds 100 pages.

Format

- A4 page size, 1” or 25.4 mm margins (top, bottom, left, right), no artistic borders on page.
- Page number position: Footer, Bottom right, Right Align.
- Title of Paper: Times New Roman, 16 Points, Bold, Title Case, Left Align. (Also known as "headline style" and "capital case" – [reference](#)).
- Name of Author(s): Times New Roman, 12 Points, Italics, Left Align. Name(s) can be supported by footnotes to include author’s designation and contact details.
- Abstract Text: Times New Roman, 12 Points, Italics, Justify.
- Heading Level 1 (Main Heading): Times New Roman, 14 Points, Bold, Left Align
- Heading Level 2 (Sub-Heading): Times New Roman, 13 Points, Italics, Left Align
- Heading Level 3 & more (under Sub-Heading): Times New Roman, 12 Points, Italic, Left Align.
- Main Text: Times New Roman, 12 Points, Justify, Single Line Spacing, No first line or hanging indentation of the paragraphs.
- Quotes or citations may be indented or set in Italics.
- Footnotes Text: Times New Roman, 10 Points, Justify, Single Line Spacing.

For your author profile, also provide:

- Your full name & title
- Your Company, University or Organization name
- Website address
- E-mail address (only visible for registered readers)
- 150-200 words on your own/your firm's professional services provided, expertise, competence...
- A digital photo (if you wish)
- LinkedIn profile link (only if you have one, it is only used for administrative purposes)
